

- 3) The competent authority on behalf of the IIT Indore does not bind him to accept the lowest or any other offer/tender and reserves to itself the authority to reject any or all the offer/tenders received without assigning any reason. All offer/tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 4) No work will be sublet to third party. If found, payment of final bill will not be processed and the contractor's name will be blacklisted from the institute without giving him further notice.
- 5) Procedure for submission of offer - offer must be submitted in sealed covers (through speed post / Courier/by person) super scribing the envelope with Tender for "**Massive forestation and plantation at simrol campus IIT Indore.**"

- 13) IIT Indore reserves the right to add/delete/amend the scope of work, if required
- 14) Rates of work order will be firm and no escalation will be paid
- 15) The rate shall include cost of all material, labour, transport, all taxes including GST; royalties etc. complete, and nothing will be paid extra.
