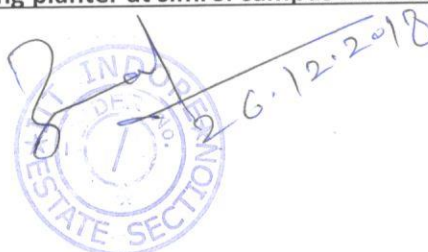

All offer/tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 4) No work will be sublet to third party. If found, payment of final bill will not be processed and the contractor's name will be blacklisted from the institute without giving him further notice.




