All offer/ tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 5) Procedure for submission of tender must be submitted in sealed covers (through speed post / Courier/ by person) super scribing the envelope with "Strengthening and enhancement the capacity of water body Lake No-7 at IIT Indore."
- 6) Tenders shall be accompanied by Earnest money in the form of FDR or online mode to Registrar IIT Indore, payable at Indore having validity for three months. The tenders without EMD will not be accepted.

- 9) Incomplete tenders, where alternate specification have been stated and rates tendered against them, tenders which are not signed by renderers at appropriate places in schedule of work, conditions of contract, tenders received late, shall be rejected without assigning any reason.
- 10) The institute reserves its right to accept lowest or any tender, enter into negotiation with any or with a group of tenderers
