- a) Essential Qualification: Masters' Degree/M.B.A. or equivalent with minimum 55% marks or equivalent grade point average with relevant experience of 03 years or B.Tech./B.E. with 06 years of experience
- b) Essential Experience: Out of the above experience minimum 1 year experience in Grade Pay of Rs. 4800/- or equivalent, handling recruitment or placement is mandatory.
- c) Upper age limit: 45 Years
