#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
