In light to the above, as per the Department for Promotion of Industry and Internal Trade (DPIIT) Office Memorandum No. P-45014/33/2021-BE-ii (e64737) dated December 20, 2022, it has been mandated that any restrictive and discriminatory conditions against local suppliers should not be part of tenders or bids. This directive ensures a fair and equitable opportunity for local manufacturers and suppliers to participate in public procurement processes. Also, GOI OM 33(3)/201724.01.2018, also notified that TCO, EPEAT, MI, Energy Star are not relevant to India & due to lack of adequate testing facilities this certification is not complied with by LOEM, and support only MNC brands. This quality certification requirement could be fulfilled by Indian quality certifications such as BEE, BIS and EPR. Thus, please allow Indian certificate as well.
